The ITS annual financial report for 2002 reflects the continued financial stability of our organization, thanks to all of our members; but some efforts in particular contributed more visibly. Financially, as a non-profit association, ITS spreads membership revenues from previous biennial conferences over two years rather than one.

As and both our thirteenth and fourteenth ITS conferences (Buenos Aires 2000, and Seoul 2002) were successful events, we are entering our 2003 fiscal year in sound financial condition. At our meeting we thanked Nakil Sung's coordination efforts, along with our other remarkably efficient Korean ITS colleagues and each and every one of our Global Sponsor organizations for their lasting contribution to our Society.

I didn't express it at the meeting, but we should also thank the Patron Saint of the ITS books, Lee Schmidt, our elected Treasurer, for his devoted monitoring and free-of-charge bookkeeping. Lee, after serving many years as the Vice President of GTE, has learned a lot about our

ITS Regional Conference Aims to Build Partnerships

European Conference Deliberates Communications Rebound

The Institut De l'Audiovisuel et des Télécommunications en Europe (IDATE) successfully concluded its 2002 conference in Montpellier last November, hosting 700 telecom, Internet and audiovisual professionals who focussed on issues surrounding the conditions required for the market's rebound.

IDATE is one of Europe's leading

market study and consulting firms, specializing in information and communication technologies. The conference

theme was the conditions required for a communications market rebound in Europe.

In his opening remarks, IDATE General Manager, Yves Gassot, stated that Europe has largely been incapable of estalishing itself as a centre for innovation and development in information and communications technologies (ICT), despite its many efforts. In his address to the delegates he said that it is necessary to pinpoint those elements that will allow Europe to "catch up".

Erkki Liikanen, European Commissioner in charge of the Information Society and Enterprises, stressed to the assembly the importance of the measures taken by the European Union, and particularly the Europe 2005 Action Plan, seeking to develop broadband communications and systems

> security. Liikanen also pointed out the need to renew investments that have suffered from operators' budget cuts.

> The demographics

of conference attendees from both private and public sectors highlighted the broad interest in European communications issues.

ITS Board Member Co-authors **New Book**

ITS Board member Xu Yan has co-authored a book with Professor Douglas Pitt of the University of Cape Town entitled Chinese Telecommunications Policy, presenting a unique review and analysis of the evolution of Chinese telecommunications policy.

It analyses the strengths, weaknesses, opportunities and threats facing new entrants, issues of ownership and interconnection, the broad economic background of 3G licensing, and the significant implications of China's accession to the WTO.

These matters are fully analyzed within the context of the unfolding Chinese regulatory system. Chinese Telecommunications Policy demonstrates that the existence of different economic and political systems forces governments to adopt different and unique regulatory approaches. The book reveals the considerable problems remaining to be solved as a result of weaknesses in Chinese telecommunications industrial and regulatory systems.

In-depth discussions in the book with key political and economic figures help the reader better understand the unique characteristics of Chinese telecommunications policies.

Xu Yan is an assistant professor in the Department of Information and Systems Management at Hong Kong University of Science and Technology. He is also an associate member of the Internet and Telecom Association of Hong Kong.

ITS-L Now Available to Members

ITS members now have listserv capability. ITS-L is the official electronic mailing list of the **International Telecommunications** Society.

Sending a message to everyone on the list is the same as sending e-mail. The listsery address is: ITS-L@csus.edu.

"Simply send an e-mail to that address and it will be relayed to everyone on the ITS-L," explained Gene Mesher, ITS-L Listowner.

He and ITS Liaison Officer, Stanford Levin, have been working on making this service available for months. The goal of the list is to facilitate professional communications among ITS members. Types of messages to be sent over ITS-L might include:

- Conference Announcements
- Job Openings
- Publications (such as journal contents and book announcements)
- Research Questions

Basically, the ITS-L uses the LISTPROC program. All LISTPROC commands must be sent in the body (not the subject line) of the message and as plain text (not html) to: LISTPROC@csus.edu

ITS members have now received a welcome to ITS-L message with directions on how to easily sign up and use the service.

However, Stanford Levin cautions that due to the volume of e-mail this generates, the ITS List should not be used as a discussion forum. Neither should it be used for personal communication such as change of contact details or self-promotion (book announcements are an exception).

ITS members are also advised not to send file attachments over the list. Instead, include the URL (Web location) of the file in the body of the message

At the discretion of the ITS Liason Officer or ITS-L Listowner, a subscriber considered to be abusing the list may be either temporarily or permanently removed.

Marketing & PR Committee

The Marketing and PR Committee has been working on the next addition of the ITS brochure. The new brochures will be ready for worldwide distribution later this spring. They will maintain the colorful design of the last brochure, and will focus on the 2004 ITS Biennial Conference to be held at the University of Colorado, Boulder Campus.

Interconnect continues to grow in terms of size and distribution. It began in February 1999 as a four page, one-fold newsletter with a printed distribution of several hundred. Most issues of Interconnect are now 6-8 pages in length with a distribution ranging from 1500 to 2200, depending upon demand.

The official website, *www.itsworld.org* also continues to add new features. Perhaps the most important recent change has been the addition of an on-line membership registration and credit card payment capability. Applicants wishing to become ITS members, or to simply renew their membership, can now do so by credit card whether by mail, fax, or directly from the ITS website.

Membership & Nominations Committee

Since the ITS Board meeting in Seoul last August, the Membership and Nominations Committee has been working to increase individual ITS memberships. Working with the ITS Secretariat, renewal letters have been sent to individual ITS members whose membership has lapsed – for instance, individuals who attended the ITS biennial meeting in Buenos Aires but who did not attend in Seoul

and who did not otherwise renew their memberships. In addition, membership letters were sent to individuals who attended other ITS conferences, but who were not ITS members.

In addition to the membership initiatives, the Membership and Nominations Committee has worked to set up a listsery that can be used by ITS members to communicate easily with all other ITS members and other interested individuals. This is an excellent way to promote conferences, to share research results, to post job openings, and generally to keep lines of communication open between ITS members and other professionals, sharing common interests. ITS member Gene Mesher at California State University Sacramento, USA, volunteered to set up and administer the listsery.

From the conference, an edited book of selected papers is being processed and edited (co-editors Erik Bohlin, Stanford Levin, Nakil Sung and Chan-ho Yoon), to be published by Elsevier North Holland Publishers. Co-editors Erik Bohlin, Stanford Levin and Nakil Sung are also preparing a special issue in *Telecommunications Policy*.

Moreover, publication plans are being formed based on the forthcoming conference to be held from June 22 - 24, 2003 in Perth, Australia. Papers submitted for the conference will be considered for a special issue in *Communications & Strategies*, the ITS Membership Journal, provided the papers meet the required quality standards and special issue theme. ITS 2004 to Focus on ICT / Economic Growth

I am honored that the University of Colorado and Boulder have been selected as the host venues of ITS 2004, and that I will be Conference Chair. "The Role of ICT on Development and Productivity" is an

important theme.

The world is rapidly moving toward an economic system based on the continuous and ubiquitous availability of information and communications technology. However, in view of the recent, drastic changes in both the international and country-specific economic environments, as exemplified by the drying up of financial markets and a general decline in economies around the world, a reexamination of the role of the ICT sector in any nation's infrastructure becomes urgent.

An understanding of the relationship between economic development, productivity and improved ICT is important.

The Fifteenth Biennial ITS Conference will address the following:

- What are the elements of a well-structured ICT system?
- What economic benefits does a well-structured ICT system provide (both quantitative and qualitative)?
- How does the adoption of ICT impact economic development and productivity growth?
- What benefits other than economic does a well-structured ICT system provide?
- Have countries/societies allocated sufficient resources to ICT?
- Is an inadequate ICT system a disincentive to new investment? Does it place existing industries at a competitive disadvantage?

A primary objective of this Conference is to define the interaction among ICT efficiency, and economic growth and development.
